Ponca High School Schedules Final Registration

Final fall registration has been scheduled for students in grades 9-12 the week of July 29-31. Every 10-12 grader will need to stop by the high school guidance office between 8:00 A.M. and 12:00 (Noon) or 1:00 P.M. to 4:00 P.M. on the day which has been set aside for his/her class to check final schedules. If there are conflicts or questions concerning a student's schedule, changes will be made at that time. Registration dates are as follows:

Seniors: Monday, July 29 Juniors: Tuesday, July 30 Sophomores: Wed. July 31

Freshmen students and their parents are urged to attend an informational meeting on Monday, July 29th, at 6:00 P.M. in the Ponca School Commons.

Mr. Lahm and Mrs. Hassler will host this meeting designed to orient 9th graders and their parents on high school requirements and class scheduling.

School Times and Procedures

The school day will start at 8:10 for Junior High and High School students with dismissal at 3:40. At Ponca Elementary, the students may enter the high school building at 8:05 with the school day starting at 8:10 and dismissing at 3:35. At Jackson Elementary, the students may enter the building through the **south doors** (the playground doors) of the building at 8:15 with the school day beginning at 8:20 and dismissing at 3:20. The shuttle bus leaves from Jackson in the afternoon at 3:20. Jackson students who ride the bus will be dismissed through the north door.

NOTE: Every Monday will be a one hour late start for our teachers to participate in Professional Learning Communities (PLCs).

Elementary Parent Night

Parent Night for elementary students at Jackson Elementary and Ponca Elementary will be Tuesday, August 13th.

Jackson Elementary is from 6:00 to 7:00, while Ponca Elementary is 7:00 to 8:00.

This is a great opportunity for parents, students, and teachers to meet and greet each other prior to the start of the school year. Students will be able to find their rooms, desks, and lockers. It is strongly encouraged that students bring their school supplies with them on this night to be placed in their desk and locker. This will eliminate a lot of confusion on the first day of school and greatly reduce the chance of losing any supplies while on the bus, or before school.

7th- 12th Grade MANDATORY Technology Meeting 17th Grade Open House

On Tuesday, August 13 at 8:00 P.M., Ponca Public Schools will be hosting the 7th-12th grade Computer Rollout in the East Gymnasium. All 7-12 parents and students should plan to meet at 8:00 pm for a **MANDATORY** meeting and important paperwork. Please bring \$25 for the computer insurance, and 9-12th grade students will receive your computer on this night.

Also taking place this night will be an Open House for all 7th grade students, their families, and the High School Buddies. The Open House will be hosted immediately following our whole group meeting in the East Gymnasium. (This replaces the Open House that has traditionally been held the following week.) All 7th grade students will sign the paperwork and pay for their Chromebooks as well as receive their 2019-2020 class schedules for the upcoming school year. High School Buddies will be the tour guides for the 7th grade students and their families, and each student will have the opportunity to walk through the school to see all of their classrooms. In addition, 7th grade students will have time to practice their locker combinations on their school lockers.

Band Instrument Rental for 5th Grade Students

If you have not yet purchased or rented an instrument, we will be having an instrument rental night on Tuesday, August 13th in the hallway by the elementary office from 7-8PM.

Stop in to get your instrument and other supplies after dropping off your school supplies. Representatives from Midbell Music will be on-site to assist you with purchases and rentals. Please bring a check or credit card, and driver's license with you. All students need their instruments in class by August 26th. DISTRICT TRANSPORTATION

*Please Note: There will be administrators and/or staff members on all bus routes the first 2 days of school. The purpose of this is to assist our students with appropriate bus behaviors and how to properly enter and exit the bus at stops.

SHUTTLE BUS TO JACKSON ELEMENTARY – Ponca Public Schools will again operate shuttle bus routes to Jackson Elementary School for students from the town of Ponca and for rural students who are transported to Ponca by means of a regular bus route. These shuttle busses will leave from Ponca Elementary for Jackson Elementary after the rural route buses have completed their morning route. The shuttle bus is scheduled to leave Ponca for Jackson promptly at 8:00am.

<u>SHUTTLE BUSSES</u> will be located on the **SOUTH** side of Ponca High School. Pre-school, Kindergarten, 1st grade, and 2nd grade students who will be attending Jackson Elementary will need to be on the bus by **8:00am**.

The shuttle busses will leave Jackson Elementary at 3:20pm to return students to Ponca in time for their rural route bus departure. Ponca Public Schools will have additional personnel available to help facilitate a smooth transition for students. District personnel will be on the morning and afternoon shuttle routes in order to supervise students.

JACKSON STUDENTS – Students within the village of Jackson should meet their bus at Jackson Elementary or the East Park in Jackson. Parents picking up students in Jackson after school can park in the school parking lot in front of the school building. The buses will load on the north side of the building.

Parking on the east side of North John Street is prohibited.

RURAL BUS ROUTES – Rural students are transported to their attendance center through the District's normal regular route system. In order to comply with bus capacity and riding time constraints, the District is still working to develop these routes and pick-up times for the 2019-2020 school year. Prior to the start of the school year, the bus drivers will be contacting families along their routes to notify of pick-up times. FAMILIES NEW TO PONCA PUBLIC SCHOOLS – Kindergarten parents needing regular route transportation and families who have moved to different addresses are encouraged to call the Superintendent's Office at 402-755-5700 for bus route information and/or approximate morning pick-up and afternoon drop-off times.

The drop-off point for ALL students riding the bus will be on the SOUTH side of the Ponca High School. ALL students will enter the Ponca school building through the SOUTH doors (Labeled #1) of the High School.

<u>Parents/guardians picking up their child after school from the elementary,</u> need to use the SOUTH doors on the SOUTH side of the High School.

If you have moved into the Ponca School District and need bus transportation for your child(ren), please call the Superintendent's Office at 402-755-5700 to inform us of your transportation needs.

- Your child's ability to see or read.
- · Your child's teeth.

If your child has health conditions such as asthma, diabetes, or behavior problems, they won't be refused health insurance.

MAP GROWTH TESTING Each year students in grades K-11 take the MAP test in the fall and winter. Elementary students are also tested in the spring. MAP is the acronym for Measure of Academic Progress. MAP is an "adaptive" measure of the learning needs of every student. At the completion of the test students receive immediate feedback on their results. Teachers use the information from MAP Growth throughout the school year to plan learning for the students in their classrooms. Students in each grade level are assessed in reading, math, language arts, and science. Administering the fall MAP test at the beginning of the school year gives teachers the opportunity to find out early the learning needs of each student and gives students information on areas they need to focus on to grow their own learning. This year the secondary students in the 7th-11th grade will MAP Growth test the first week of school.

Throughout the school year, please check your **LUNCH FUND BALANCE** in PowerSchool to ensure your child(ren) have adequate funds available. I realize that your lunch bill is an additional expense for your family, but be careful to not allow your bill to get out-of-hand. Please pay your lunch bill on a timely manner, it allows the school district to get our bills paid.

Please apply for the free or reduced priced lunches as the school receives Federal and State reimbursement funds for every meal served. The main components of receiving free or reduced priced lunches are based on family income and the number of total family members living in the household. Every family should fill out the form to find out if they meet the necessary qualifications. Please know that all information is kept confidential and only used for the purpose of determining qualification for free or reduced lunch. There is nothing embarrassing about applying for free or reduced priced lunches. When your child enters their lunch account number on the lunch computer, there is NO indication of the payment status.

Again, ALL Free or Reduced priced lunch information is kept strictly CONFIDENTIAL.

Lunch accounts are set up as individual accounts. **DID YOU KNOW YOU CAN PAY ONLINE!!!!!** Ponca Public School District is happy to be partnered with e~Funds for Schools so that parents have the ability to pay online.

Will Your Child Be Able to Start School This Fall??

Kindergarteners must have a physical, eye exam, and kindergarten shots and birth certificate. 7th graders must have a physical, tetanus booster. If your child does not meet the state required items listed above, they will be sent home the first day of school. They will not be able to return to school until we receive the State required items. Please schedule your appointments as soon as possible.

Student/Parent Handbooks

Student/Parent Handbooks will be sent via email and will be available on the school website. If you do not have access to the electronic form of the handbook, you may request one from the elementary or secondary office. Please review the handbook information with your student(s).

We require a signed signature page stating that you have access to the handbook in electronic form or have received a copy of it. Only one signature per family needs to be returned to the school. If you have children in both elementary and secondary, please have a 7-12 child return the signature page to the high school Principal's office. If you only have elementary children, please have your child return it to their classroom teacher.

Legal School Age - Enrollment in Kindergarten

Every child who, on or before the 1st day of August in any year, shall have attained the age of five years and who has not attained the age of 21 years shall be deemed to be of legal school age. Enrollment in kindergarten is available to children who live within the Ponca Public School district boundaries and who are five (5) years of age or will be five (5) years of age by August 1st of the year of their enrollment. The only exception to this rule is in the case of an incoming transfer student who has been enrolled in a kindergarten program in another school district during the present school year and has not reached five (5) years of age by October 15.

Dear Parent/Guardian:

Children need healthy meals to learn. Ponca Public Schools offers healthy meals every school day. Lunch costs are: PreK-2 = \$2.75/ Grades 3-6=\$3.00/Grades 7-12=\$3.25. Your children may qualify for free or reduced price meals. Reduced price is \$.40 for lunch. If your child(ren) qualified for free or reduced price meals at the end of last school year, you must submit a new application by September 25, 2019 in order to avoid an interruption in meal benefits.

This packet includes an application for free or reduced price meal benefits and a set of detailed instructions. Below are some common questions and answers to help you with the application process.

- 1. WHO CAN GET FREE OR REDUCED PRICE MEALS?
 - All children in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP), Temporary
 Assistance for Needy Families (TANF) or the Food Distribution Program on Indian Reservations (FDPIR) are eligible for
 free meals.
 - Foster children that are under the legal responsibility of a foster care agency or court are eligible for free meals.
 - Children participating in their school's Head Start program are eligible for free meals.
 - Children who meet the definition of homeless, runaway, or migrant are eligible for free meals.
 - Children may receive free or reduced price meals if your household's income is within the limits on the Federal Income Eligibility Guidelines. Your children may qualify for free or reduced price meals if your household income falls at or below the limits on this chart.
- 2. HOW DO I KNOW IF MY CHILDREN QUALIFY AS HOMELESS, MIGRANT, OR RUNAWAY? Do the members of your household lack a permanent address? Are you staying together in a shelter, hotel, or other temporary housing arrangement? Does your family relocate on a seasonal basis? Are any children living with you who have chosen to leave their prior family or household? If you believe children in your household meet these descriptions and haven't been told your children will get free meals, please call or e-mail Supt. Jody L. - 4. SHOULD I FILL OUT AN APPLICATION IF I RECEIVED A LETTER THIS SCHOOL YEAR SAYING MY CHILDREN ARE ALREADY APPROVED FOR FREE MEALS? No, but please read the letter you got carefully and follow the instructions. If any children in your household were missing from your eligibility notification, contact **Supt. Jody L. Phillips, Ponca Public Schools, PO Box 568, Ponca, NE 68770. Phone: (402) 755-5700 Email: jodyphillips@poncaschool.org immediately.**
- 5. MY CHILD'S APPLICATION WAS APPROVED LAST YEAR. DO I NEED TO FILL OUT A NEW ONE? Yes. Your child's application is only good for that school year and for the first few days of this school year. You must send in a new application unless the school told you that your child is eligible for the new school year. If you do not send in a new application that is approved by the school or you have not been notified that your child is eligible for free meals, your child will be charged the full price for meals.
- 6. I GET WIC. CAN MY CHILDREN GET FREE MEALS? Children in households participating in WIC <u>may</u> be eligible for free or reduced price meals. Please send in an application.
- 7. WILL THE INFORMATION I GIVE BE CHECKED? Yes. We may also ask you to send written proof of the household income you report.
- 8. IF I DON'T QUALIFY NOW, MAY I APPLY LATER? Yes, you may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free and reduced price meals if the household income drops below the income limit.

- WHAT IF I DISAGREE WITH THE SCHOOL'S DECISION ABOUT MY APPLICATION? You should talk to school officials. You also may ask for a hearing by calling or writing to: Kenton Book, Board President, 505 3rd Street, Ponca NE 68770 (402)755-5700.
- 10. MAY I APPLY IF SOMEONE IN MY HOUSEHOLD IS NOT A U.S. CITIZEN? Yes. You, your children, or other household members do not have to be U.S. citizens to apply for free or reduced price meals.
- 11. WHAT IF MY INCOME IS NOT ALWAYS THE SAME? List the amount that you <u>normally</u> receive. For example, if you normally make \$1000 each month, but you missed some work last month and only made \$900, put down that you made \$1000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.
- 12. WHAT IF SOME HOUSEHOLD MEMBERS HAVE NO INCOME TO REPORT? Household members may not receive some types of income we ask you to report on the application, or may not receive income at all. Whenever this happens, please write a 0 in the field. However, if any income fields are left empty or blank, those will also be counted as zeroes. Please be careful when leaving income fields blank, as we will assume you meant to do so.
- 13. WE ARE IN THE MILITARY. DO WE REPORT OUR INCOME DIFFERENTLY? Your basic pay and cash bonuses must be reported as income.
