Minutes of the Regular Meeting of the Board of Education of Ponca Public Schools February 18, 2019 7:00 p.m.

The Board of Education of Dixon County School District 1 (also known as Ponca Public Schools) held a regular meeting on Monday, February 18, 2019 in the Ponca Public Schools Library at 505 West 3rd Street, Ponca, NE. The meeting was convened in open and public session and advance notice was publicly posted at the Bank of Dixon County, the Dixon County courthouse, the post office and the school house door, published in the Nebraska Journal Leader, and given to all members of the Board of Education.

Vice President Burki called the regular meeting to order at 7:00 p.m., informed the public that a current copy of the Open Meetings Act is posted on the wall of the meeting room, and led the salute to the flag. Principal Hayes reported on the Ponca State Park favorite winter activity contest winners, Connor Schamp's participation in a state robotics contest, the sixth graders' orientation project, Jackson elementary roller skating on February 14th, and the elementary teachers starting a new reading assessment program.
