Minutes of the Ponca Public Schools Board of Education Regular Meeting June 18, 2018 7:30 p.m.

A meeting of the Board of Education of Ponca Public Schools was convened in open and public session on Monday, June 18, 2018 at 7:30 p.m. in the fine arts auditorium of the Ponca Public Schools, 505 3rd Street, Ponca, Nebraska. Notice of the meeting was given in advance by publication and posting in accordance with the Board approved method for giving notice of meetings. Notice of this meeting was given in advance to all members of the Board of Education. Availability of the agenda was communicated in the publicized notice and a current copy of the agenda was kept continuously current and available for inspection at the office of the Superintendent of Schools. All proceedings of the Board of Education, except as may be hereinafter noted, were taken while the convened meeting was open to the attendance of the public.

Vice President Monte Burki called the meeting to order at 7:30 p.m., informed the public that a current copy of the Open Meetings Act is posted on the wall of the meeting room, and led the salute to the flag. The following Board members were present: Burki, Dohma, Fethkenher, Gill, Kramper. Absent: Book. Also present were Supt. Phillips, Princ. Lahm, Andy Stark, Sec. Huston and 1 visitor. Principal Hayes was attending a school activity.

Kramper moved to excuse absent member Book. Fethkenher seconded the motion. Voting Aye: Burki, Dohma, Fethkenher, Gill, Kramper. M.C.

There were no requests to speak before the Board.

Dohma moved to approve the consent agenda. Gill seconded the motion. Voting Aye: Burki, Dohma, Fethkenher, Gill, Kramper. Absent: Book. M.C. The consent agenda included approval of the agenda, the minutes of the May 21, 2018 meeting, the treasurer's report showing a general fund balance of \$1,373,092.03; a depreciation fund balance of \$151,707.07; a bond fund balance of \$538,774.87; a special building fund balance of \$398,782.60; an employee benefit fund balance of \$1,487.81; an activity fund balance of \$184,367.06; a school nutrition fund balance of \$6,664.31; and general fund disbursements of \$157,283.42. Credit card payments and the payroll report were also approved.

<u>Supt. Phillips</u> updated the Board on the sale of the Art building, the disposal and sale of stored items in the portable building, the planting of trees, administration options for the IRS 125 account, the attempt at conversation with Laurel-Concord-Coleridge on a softball co-op, the Spanish teacher opening, the volleyball coach opening, the sprinkler system, and a daycare in Jackson. The Art building auction will be held online on the following website: http://www.delpeterson.com and will end on July 10, 2018.

Principal Lahm congratulated the athletes and their coaches who participated in the Northeast Nebraska all-star games. He also acknowledged Dalton Tremayne's selection by Norfolk Daily News as the Area Student-Athlete of the Year. Principal Lahm presented information on the Map Growth results, ACT testing, NSCAS summative scores, and talked about the differences in the testing result response times. He reviewed the highlights of his first year in Ponca and thanked the teachers for their hard work.

In Athletic Director Hayes' absence, Supt. Phillips spoke about the desire to have a 4th high school sports season during the summer for school baseball and softball mainly for class C and D schools.

Andy Stark gave the technology report.
