Minutes of the Regular Meeting of the Board of Education of Ponca Public Schools June 17, 2019 7:30 p.m.

The Board of Education of Dixon County School District 1 (also known as Ponca Public Schools) held a regular meeting on Monday, June 17, 2019 in the Ponca Public Schools Library at 505 West 3rd Street, Ponca, NE. The meeting was convened in open and public session and advance notice was publicly posted at the Bank of Dixon County, the Dixon County courthouse, the post office and the school house door, published in the Nebraska Journal Leader, and given to all members of the Board of Education.

President Book called the regular meeting to order at 7:30 p.m., informed the public that a current copy of the Open Meetings Act is posted on the wall of the meeting room, and led the salute to the flag. Roll call was taken. Members present were Book, Burki, Dohma, Fethkenher, Gill and Kramper. Others present included Supt. Phillips, Principal Lahm, Andy Stark, Sec. Lorrie Huston and two visitors. Principal Hayes was absent due to attending a girls' basketball team camp.

There were no requests to speak before the Board.

The consent agenda was approved on a motion by Dohma and a second by Fethkenher. Voting Aye: Book, Burki, Dohma, Fethkenher, Gill and Kramper. M.C.U. The consent agenda included approval of the agenda, the minutes of the May 20, 2019 meeting, financial reports consisting of the treasurer's report showing a general fund balance of \$1,295,304.19; a depreciation fund balance of \$141,888.41; a bond fund balance of \$476,044.70; a special building fund balance of \$313,657.35; an employee benefit fund balance of \$1,493.99; an activity fund balance of \$217,641.86; a nutrition fund balance of \$4,382.09; and claims and accounts consisting of general fund disbursements of \$52,747.45, credit card payments and the June payroll report.
