At 7:18 p.m., the Board entered into executive session for the protection of the reputation of an individual on a motion by Burki, second by Book. Voting Aye: Gill, Kramper, Rickett, Book, Burki, Dohma. M.C. 6-0. The executive session was declared over at 7:20 p.m.
